



## INTRO

### ROUTE SETTING BASICS

- **FORMAT:** Online or in person
- **AUDIENCE:** General wall staff, reception staff, new setters and/or strippers
- **PREREQUISITES:** 16 years with parental consent
- **LENGTH:** 1 day
- **REMIT:** supervised boulder setting/stripping and unsupervised tightening of spinners
- **RE-VALIDATION:** resit the course assessment every 3 years if no further qualifications

## DEVELOPMENT

### SETTING IN PRACTICE TRAINING AND ASSESSMENT

- **FORMAT:** In person training and assessment
- **AUDIENCE:** novice setters & strippers
- **PREREQUISITES:** Route Setting Basics, have climbed on average once a week for 6 months
- **LENGTH:** 1 day
- **REMIT:** independent setting/stripping of bouldering at any centre
- **RE-VALIDATION:** resit the course every 3 years or evidence of active practice & 15 hours CPD every 3 years

### LOGGED QUALITY BOULDER SETTING DAYS

- evidence of a minimum of 20 quality setting and stripping shifts, including troubleshooting simple stuck holds

### COMMERCIAL BOULDER SETTER TRAINING AND ASSESSMENT

- **FORMAT:** In person training and assessment
- **AUDIENCE:** setters with some experience
- **PREREQUISITES:** Route Setting Basics, Setting In Practice, minimum 20 quality boulder setting days
- **LENGTH:** 2 days
- **REMIT:** able to use rope systems to haul volumes into and lower volumes out of place able to apply for headsetter positions
- **RE-VALIDATION:** half day practical reassessment, Industry Updates Module & 15 hours of CPD every 3 years

### COMMERCIAL ROPED SETTER TRAINING

- **FORMAT:** In person training
- **AUDIENCE:** setters with some experience
- **PREREQUISITES:** Route Setting Basics, Setting In Practice
- **LENGTH:** 2 days
- **REMIT:** supervised roped setting at a variety of centres on a variety of angles at the discretion of the supervisor
- **RE-VALIDATION:** none required on the assumption assessment has been completed

### LOGGED QUALITY ROPED SETTING

- evidence of a minimum of 15 roped routes set and stripped, including attaching larger holds as well as troubleshooting simple stuck holds

### COMMERCIAL ROPED SETTER ASSESSMENT

- **FORMAT:** In person assessment
- **AUDIENCE:** setters with some experience
- **PREREQUISITES:** Route Setting Basics, Setting In Practice, Commercial Roped Setter Training, minimum 15 routes set and stripped
- **LENGTH:** 1 day
- **REMIT:** unsupervised roped setting at a variety of centres on a variety of angles
- **RE-VALIDATION:** half day practical reassessment, Industry Updates Module & 15 hours CPD every 3 years
